

The Day I Discovered the Giant's Marbles By Paul Berthelot

It happened while I was on holiday in New Zealand; ~ rather ~ on a "working sabbatical". The wife was shopping at some of Moeraki's more trendy Shoppe's and I was taking advantage of her absence ~ although I certainly would notice the repercussions of her excursion at a later date.

As I had some free time {& the wife otherwise was occupied} I hired a guide for an afternoon hike along some of the country's more rugged countryside. I must note that anybody who knows me realizes how "rugged" I actually am &, no doubt would find such a euphemism hilarious. Be that as it may, my guide & I set out to see what would turn up.

We were walking along New Zealand's Otago coastline when I observed some large round objects in the distance. As we drew near & I could more clearly see what I had glimpsed earlier I thought I was dreaming ~~ or at least had lost what little common sense I had left.

My guide began by telling me the "marbles" were much older than one would think possible. "Laddie," he said in his gentle burr, "these stone boulders are verrrry old. Aye, they're much older than your giants. And since they weigh several tons & some measure up to three metres in diameter, it would take a prodigious giant to lift them."

A cloud of doubt crossed my mind but I managed to keep my mouth from rambling. Oh," I muttered quietly. Obviously my guide was too practical to even believe in giants. To deny that giants existed was to court a fate worse than death ~~ or so I'd been told when a youngster.

There is also a slight change in the number of pages in one category so take a good look at the rules. Sylvia Nasholm won the Adult Articles category with her story about the Kern County Mineral Mites.
- 5. The 2011 CFMS Show will be held in Anderson, CA on May 13 –15, 2011. That's a far away place up North. www.superiorcal.com
- 6. The Bay Area Searchers remain delinquent and the North Island GMS has disbanded.
- 7. The combined dues and insurance fee of \$8.00 per member as of 31 December remains in effect.
- 8. I received a 7-page document consisting of the 2010 CFMS Supplementary Rules. These are in addition to the AFMS Uniform Rules to cover classes not given there or for special CFMS only exhibits. Anyone that wants a copy please contact me.
- 9. The 2010 AFMS/CFMS show will be held in the City of La Habra, CA on June 16-20, 2010. The main show will be at the Southern California University of Health Sciences. Headquarters for the show will be the Anaheim Park Hotel in Fullerton, CA. The CFMS Cracker Barrel will be held at the Friendly Village, 1001 W Lambert Rd., La Habra, CA. The CFMS Directors meeting will be held at the La Habra Community Center, 101 W La Habra Blvd., in La Habra. The AFMS/CFMS editors breakfast will be held 6/20/10 at 7 am in the Anaheim Park Hotel. The cost is \$21.00 for the breakfast. I will be making up packets for the show for use by OMS members wishing to attend the show. Exhibit entry deadline is May 15, 2010
- 10. The CFMS has made a contract with Darryl Powell of Diamond Dan Publications for a two-year subscription of Mini Miners Monthly, a kid's magazine. The CFMS also decided to include those CFMS clubs who have declared they have a juniors program in effect. That means 72 clubs

will receive it at a cost of \$900.00. I have no idea as to when it will start.

Last Friday, at the urging of my friends, Fred Ward and Robyn Hawk, and since I was leaving Marty Zinn's, West Coast Gem & Mineral Show, in Costa Mesa (CA), I decided to check out the new NEVADA MINERAL AND BOOK COMPANY store, in near by, Orange, CA. It was "freeway close" and easy to find, except they did not have their sign up, yet. I was expecting a dark & dusty "Rock Shop" and was wonderfully surprised when I found this beautiful, bright, "UNIQUE EARTH SCIENCE BOOKSTORE & NATURAL HISTORY GALLERY".

The owners, Walt Lombardo (a retired Nevada State Geologist) and his wife, Sandy (a Biologist, Certified Gemologist, and Teacher), relocated back to Orange County, and moved their Las Vegas area "earth science bookstore & natural history gallery" to the city of Orange, CA. They say they are there for: professional and amateur Geologists; Gemologists; Prospectors; and Collectors; plus Teachers; Rockhounds; Libraries; Museums; Universities; and Mining & Engineering Companies.

There are actually, two stores, next to each other. The main store is "The Gallery", with the walls lined with books (old & new), magnificent mineral specimens, fossils, artifacts, etc., and photographs. In the center, there are beautiful dark wood cabinets, and glass display cases, stuffed with wonderful, reasonably priced, smaller specimens & fossils, meteorites, educational kits, and unique color stone jewelry. And then there is a large alcove for special exhibits and live events.

The second store, is filled with metal racks, stacked high with, what is probably the world's greatest collection of, publications devoted to Geology, Mining, Gemstones, Fossils, and other Geologic Sciences. There are books, magazines, publications, and maps (some relatively new, and some very old). 


