John Martin PLAC-South 2011

S-138 California Desert Protection Act of 2011 (0 Cosponsors) A bill to provide for conservation, enhanced recreation opportunities, and development of renewable energy in the California Desert Conservation Area, and for other purposes. What this Bill will do. It will create:

MOJAVE TRAILS NATIONAL MONUMENT authorize the continued recreational uses of the monument (including hiking, camping, hunting, mountain biking, sightseeing, off-highway vehicle recreation on designated routes, rockhounding, and horseback riding), if the recreational uses are consistent with this section and any other applicable law;

ADVISORY COMMITTEE.

A representative from each of the following recreational activities:

- ‘(A) Off-highway vehicles.
- ‘(B) Hunting.
- ‘(C) Rockhounding.

SAND TO SNOW NATIONAL MONUMENT authorize the continued recreational uses of the monument (including hiking, camping, hunting, mountain biking, sightseeing, off-highway vehicle recreation on designated routes, rockhounding, and horseback riding), if the recreational uses are consistent with this title and any other applicable law.

IN GENERAL- The Secretary shall continue to authorize, maintain, and enhance the recreational uses of the off highway vehicle recreation areas designated by subsection (a), including off-highway recreation, hiking, camping, hunting, mountain biking, sightseeing, rockhounding, and horseback riding, as long as the recreational use is consistent with this section and any other applicable law.

HR 1581 Wilderness and Roadless Area Release Act (22 Cosponsors)

BLM manages over 12.27M acres in 546 Wilderness Study Areas (WSA). BLM has recommended that 6.72M acres of WSAs under its jurisdiction are not suitable for a wilderness designation.

Relating to Inventoried Roadless Areas USFS identified roadless areas in the National Forest System. RARE II recommended 15M acres to be designated as wilderness, 36.1M acres as not suitable for wilderness, and 10.7M acres needed further study. *Relating to Wilderness Study Areas.* This legislation would release Wilderness Study Areas recommended by BLM as not-suitable for a Wilderness Area designation from the requirement under current law (Section 603(c) of FLMPA) that these areas be managed as wilderness. The bill directs BLM to manage the released lands in accordance with multiple-use and sustained-yield provisions of Section 202 of FLMPA.

Relating to Inventories Roadless Areas This legislation would release roadless areas within the National Forest System, which have been recommended as not suitable for a wilderness designation by the Forest Service (as part of the second Roadless Area Review and Evaluation Program) from being managed to maintain roadless characteristics/values, as well as any land-use restrictions imposed the lands as part of the 2001 Roadless Area Conservation Rule or the 2005 State

Petition Rule. The bill directs the Forest Service to manage the released roadless areas in accordance the principles of the Multiple-Use Sustained-Yield Act of 1960.

This BILL needs our support – Write your elected official and ask them to support this legislation.

Clear Creek Management Area

New Report Examines Asbestos Exposure at Clear Creek Management Area near Hollister, California.

The Off-Highway Motor Vehicle Recreation (OHMVR) Division of California State Parks today released a new independent report analyzing naturally occurring asbestos exposures associated with motorcycle riding and hiking in the U.S. Bureau of Land Management's (BLM) Clear Creek Management Area (CCMA). The report was completed by scientists from the International Environmental Research Foundation (IERF), the Department of Physics at Harvard University, and the Center for Applied Studies of the Environment at the City University of New York. The OHMVR Division commissioned the IERF report to gather more data to determine if management and operational strategies could be employed at the CCMA to mitigate risk while still allowing access to this premier off-highway vehicle (OHV) recreation destination.

Conclusion: Although it is not for the IERF study to decide what, if anything, to do about riding or hiking on the trails in the CCMA, we believe that this preliminary study provides a spot check on the two earlier studies and show that the risk to health from inhaling asbestos from trail riding and hiking at certain times can be very small. It is, however, desirable to study further the following: The tremolite fragments were found only in the motorcycle air samples indicating it is not uniformly distributed in the serpentine. Additional studies to strengthen our conclusion that tremolite asbestos or other amphibole asbestos types are not present would be useful. !It might be helpful to verify that at any one of the day camp areas the level of fibers is indeed as low as we reported here for the area samples. The airborne asbestos levels observed in this study are similar to background for asbestos in the ambient air. The number of days per year when similar condition will exist at CCMA has not been determined. Since the conclusions of this preliminary study conflict with

the conclusions of other published studies, it would be helpful to examine the other two other studies in more detail, including examination of samples collected for the other studies using ATEM to see whether there is a real discrepancy and if so how these discrepancies can be resolved. This will now require that all three studies be taken into consideration when making a final decision on the use of CCMA for recreational purposes.

Rockhound State Park, New Mexico

Rockhound State Park may have been saved because of the letters written to the state park officials and the public outcry at the public meeting held in Deming, New Mexico. Letters of support for continued collecting within the state park were received from rockhounds all over the country. These letters and the public support at the local meeting have persuaded the park officials to re-examine their position on rock collecting. As of now the Management Plan is being revised and will be released to the public shortly. We will then see if rock collecting is still allowed in Rockhound State Park and if the park has really been saved. Thank you to all who did contact the park officials and voiced their concern the rock collecting issues at Rockhound State Park. Your voices were heard and you did make a difference.

Special BLM Recreation Permit Follow up

There seems to be a lot of confusion on this issue. Having spoken with the recreation officer at Needles BLM those permits are necessary ONLY if you're charging for being on a trip. Otherwise it still falls under recreational collecting which is why CFMS was never bothered by BLM on trips. If you still feel the need to "CYA" then file an online email Notice of Intent stating where, when and how many will attend and that you'll abide by BLM/NFS collecting and road use rules. If you're charging others to attend a trip, THEN you have to fill out the permit forms and pay fees.

BTW, in my opinion a Notice of Intent also shows rockhound use of an area and stays on file in case of threat of closures.

BLM Update – El Paso Mountains

From L.A. Rocks

There's been a lot happening regarding access in the El Paso Mountains, and renewable energy in

Indian Wells Valley. The latest BLM meeting explained that due to the WEMO related lawsuit in San Francisco by the Citizens for Biological Diversity, and resultant finding in their favor, the BLM must re-justify all access roads it has marked. My friend Last Chance Charlie remembers in 1987 or so when a low flying aircraft was seen a lot over Bickel Camp area, shortly after there had been a good rainfall which unfortunately covered many routes. The "data" from these flights is what's now being used by the BLM to mark routes that existed then, and the marking of those routes is now being done in the El Pasos. Routes seen today without markers are considered closed from the BLM's point of view. At the end of the route marking, sometime in 2014, the public is allowed a comment period to lobby for route designation according to the latest BLM meeting. The BLM has also already culled duplicate routes, and dead end routes, so what we'll see marked in the next couple of weeks in the hills up there will not be all that existed even back then. Maps have not been distributed of the route system, so lots of questions are in the air regarding our access to rock hounding, 4wd routes, view spots, hunting areas, favorite camping areas, etc. Charlie will attempt to get some maps and distribute as soon as they're available. Charlie also believes the BLM will enact a fee based access sticker for the El Paso's someday soon.

Bench Tips

TOOTHPICKS - The round, stronger toothpicks have a multitude of uses on the jewelry bench. I use them for mixing epoxy resin, for applying paste solder, with Zam for polishing in tight spots, and with a bit of beeswax for picking up and positioning small stones. They're particularly good for testing the fit of a small faceted stone in a prong or tube set finding.

PUMICE WHEELS - Pumice wheels are good for touching up a bezel after you've set the stone. The hardness is about 6 on the Moh's scale, less hard than quartz, so it shouldn't scratch any of your jaspers. However, I'd avoid or be real careful of using pumice near the softer stones like turquoise, amber, howlite, etc. If you're unsure that a wheel is pumice, test it with a piece of glass. Glass is about 5 ½ on the Moh's scale. If it doesn't scratch glass, it shouldn't scratch quartz.

MAGNETIC PIN FINISHER - There is a good article about making your own magnetic tumbler at <http://www.rchristopher.com/tech/tumbler.html>

The person reporting this on the Yahoo Groups Jewelry Casting list says he's made two units from these plans and they work very well. In addition to the primary job of burnishing and polishing finished pieces, he also uses the units for cleaning investment from castings. The stainless

steel pins are available from either Gesswein or Rio Grande in Albuquerque.

When drilling a small hole into a small piece, many folks try to hold the piece by hand. But if the drill sticks, the piece will start to spin and possibly slice your finger. Having done this occasionally in my younger days, I avoid Band-Aids now by using flat-jaw pliers to hold small pieces on the edge of the bench pin or on a piece of wood when using the drill press.

The little 3" square steel bench block gets plenty of use and abuse. When I started to see scars on the face of my block I grabbed one of the magnetic 3" square advertisements (usually from lawyers) from the front of the new phone book and stuck it on the best side of the block. After a couple of years the block has one pristine (almost) side and one side that shows all the fun I've been having. When I need/want good, I still have it.
